

ORDINANCE 195

AN ORDINANCE AMENDING SECTION 3.2 (BASIS FOR ESTABLISHING THE AREA OF SPECIAL FLOOD HAZARD) OF ORDINANCE NO. 158 ENTITLED "AN ORDINANCE ESTABLISHING REQUIREMENTS FOR CONSTRUCTION WITHIN THE SPECIAL FLOOD HAZARD AREAS OF THE VILLAGE OF LOCH ARBOUR; ESTABLISHING PROCEDURES FOR ISSUANCE OF PERMITS FOR SUCH CONSTRUCTION; DESIGNATING THE CONSTRUCTION OFFICIAL TO ADMINISTER AND IMPLEMENT SUCH REQUIREMENTS AND PROCEDURES; PROVIDING FOR APPEAL FROM DETERMINATIONS OF THE CONSTRUCTION OFFICIAL AND PROVIDING FOR AND ESTABLISHING PROCEDURES FOR OBTAINING VARIANCES FROM CONSTRUCTION REQUIREMENTS" SO AS TO INCORPORATE BY REFERENCE A SCIENTIFIC AND ENGINEERING REPORT ENTITLED "THE REVISED FLOOD INSURANCE STUDY OF LOCH ARBOUR DATED MARCH, 1983" AND THE ACCOMPANYING "FLOOD INSURANCE RATE MAP AS REVISED SEPTEMBER 15TH, 1983".

BE IT ORDAINED, by the Board of Trustees of the Village of Loch Arbour, in the County of Monmouth and State of New Jersey, that the Ordinance referred to in the title hereof is amended and supplemented as follows:

Section 1. Section 3.2 (Basis for Establishing the Areas of Special Flood Hazard) of Ordinance No. 158 is hereby amended to read as follows:

The areas of special flood hazard identified by the Federal Insurance Administration through a scientific and engineering report entitled "The revised Flood Insurance Study of Loch Arbour dated March, 1983" and the accompanying "Flood Insurance Rate Map as revised September 15th, 1983" is hereby adopted by reference and declared to be a part of this Ordinance. The Flood Insurance Study is on file at the office of the Village Clerk, 550 Main Street, Loch Arbour, New Jersey.

Section 2. All Ordinances or parts of Ordinances in consistent herewith are repealed, but only to the extent of such inconsistency. All parts of Ordinance No. 158 not inconsistent herewith are hereby ratified and confirmed.

Section 3. This Ordinance shall take effect immediately upon its final passage and publication as required by law.

PUBLIC NOTICE is hereby given that the foregoing Ordinance was introduced at a meeting of the Board of Trustees of the Village of Loch Arbour, in the County of Monmouth and State of New Jersey, on the 7th day of July, 1983, and was then read for the first time.
