

ORDINANCE 67

AN ORDINANCE PROVIDING FOR THE REGULATION AND CONTROL OF VEHICULAR TRAFFICE AND PARKING UPON THE STREETS, HIGHWAYS AND ROADS IN THE VILLAGE OF LOCH ARBOUR, AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF, AND SPECIFICALLY REPEALING ORDINANCES NO. 10, 22, 23 AND 34, AND ANY AND ALL OTHER ORDINANCES AND SECTIONS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED, by the Board of Trustees of the Village of Loch Arbour, in the County of Monmouth and State of New Jersey, as follows:

ARTICLE I – Definitions:

Section 101. All terms used in this Ordinance shall be defined as set forth in Title 39 (Motor Vehicles and traffic Regulations) of the Revised Statutes of the State of New Jersey.

ARTICLE 2 – Official Time Standard:

Section 201. Whenever certain hours are named herein, they shall mean either Eastern Standard Time or Eastern Daylight Savings Time, as may be in current use in the Village of Loch Arbour.

ARTICLE 3 – Parking Prohibitions, Limits and Methods:

Section 301. When appropriately signed, no person shall park a vehicle at any time:

- (a) On the west side of Ocean Place between Edgemont Drive and Euclid Avenue;
- (b) On the west side of Ocean Place, also known as Ocean Road, between Euclid Avenue and Elberon Avenue;
- (c) On the north side of Edgemont Drive starting at a point at the northeast corner of Edgemont Drive and Main Street, running thence easterly along the north side of Edgemont Drive for a distance of 150 feet;
- (d) On the south side of Edgemont Drive starting at a point at the southeast corner of Edgemont Drive and Main Street, running thence easterly along the south side of Edgemont Drive 100 feet;
- (e) On the north and south sides of Euclid Avenue, east of Ocean Place;
- (f) On the south side of Elberon Avenue, east of Ocean Place.

Section 302. When appropriately signed, no person shall park a vehicle for a period of more than two hours continuously between the Hours of 8 A.M. and 2P.M. on any of the following streets of the Village of Loch Arbour:

- (a) Along the south side of Euclid Avenue beginning at the intersection of Euclid Avenue and Edgemont Drive, thence easterly to the corner of Euclid Avenue and Evergreen Place;
- (b) Along the north side of Euclid Avenue beginning at the northeast corner of Page Avenue and Euclid Avenue, then running easterly for a distance of 288 feet;
- (c) Along the east and west sides of Page Avenue beginning at its intersection with Euclid Avenue and thence running in a northeasterly direction to the Borough of Allenhurst boundary line;
- (d) Along the south side of Edgemont Drive beginning at a point 100 feet from the intersection of Edgemont Drive and Main Street, thence in an easterly direction to the intersection of Edgemont Drive and Norwood Avenue;

- (e) Along the north side of Edgemont Drive beginning at the intersection of Edgemont Drive and Euclid Avenue, thence in an easterly direction to the intersection of Edgemont Drive and Norwood Avenue;
- (f) Along the east side of Main Street beginning with its intersection with Edgemont Drive and thence running in a northerly direction to the Borough of Allenhurst Boundary Line.

Section 303 When appropriately sign, from the 15th day of May to the 15th day of September (both dates inclusive) in each year, no person shall park a vehicle at any time along the east and west sides of Ocean Avenue beginning at its intersection with Edgemont Drive and thence running in a northerly direction to its intersection with Euclid Avenue.

ARTICLE 4 – Penalties and Enforcement:

Section 401. Unless another penalty is expressly provided by the statutes of the state of New Jersey, every person convicted of a violation of this Ordinance, or any amendments thereof or supplements thereto, shall be liable to a penalty of not more than Fifty (\$50.00) Dollars for each offence, or may be imprisoned in the County Jail for a period not exceeding fifteen (15) days for each offence, or both, in the discretion of the municipal magistrate of the Village of Loch Arbour.

Section 402. All complaints under the within Ordinance shall be made before the municipal magistrate of the Village of Loch Arbour, or such person legally acting in his place and stead, as provided by law.

ARTICLE 5 – Repealer and Saving Clause:

Section 501. Ordinance Nos. 10,22, 23 and 34, and any and all other Ordinances and sections and parts of other Ordinances of the Village of Loch Arbour, in conflict and inconsistent with this Ordinance, are hereby repealed.

Section 502. If, for any reason, any Article, section, part of any section, or any provision, of this ordinance shall be questioned in any Court, and shall be held to be unconstitutional or invalid, the same shall not be held to affect any other Article, section, part of any section or provision, of this Ordinance.

ARTICLE 6 – Effective Date:

Section 601. The within Ordinance shall become effective immediately upon final passage and publication and approval by the Director of Motor Vehicles of the Department of Law and Public Safety of the State of New Jersey, as provided by law.
