

ORDINANCE NO. 313

AN ORDINANCE TO AMEND ORDINANCE NO. 67 ENTITLED "AN ORDINANCE PROVIDING FOR THE REGULATION AND CONTROL OF VEHICULAR TRAFFIC AND PARKING UPON THE STREETS, HIGHWAYS AND ROADS IN THE VILLAGE OF LOCH ARBOUR, MONMOUTH COUNTY, AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF, AND SPECIFICALLY REPEALING ORDINANCES NO. 10, 22, 23 AND 34 AND ALL OTHER ORDINANCES AND SECTIONS OF ORDINANCES IN CONFLICT THEREWITH" BY ADDING A SECTION THERETO RELATING TO THE PROHIBITION OF STOPPING AND STANDING WITHIN THE INTERSECTION OF OCEAN PLACE AND EUCLID AVENUE, CREATION OF LOADING AND UNLOADING ZONES ON THE NORTH AND SOUTH SIDES OF EUCLID AVENUE AT OCEAN PLACE, AND THE PROHIBITION OF PARKING ON THE East Side OF OCEAN PLACE AT THE INTERSECTION WITH EDMONT DRIVE AND REPEALING ANY AND ALL ORDINANCES IN CONFLICT THEREWITH.

BE IT ORDAINED by the Board of Trustees of the Village of Loch Arbour, County of Monmouth, State of New Jersey, as follows:

Section 1. Article 3 of Ordinance No. 67 is supplemented as follows:

- a. Stopping or standing is prohibited within the intersection of Ocean Place and Euclid Avenue beginning at a point fifteen feet north of the centerline of the corner of Euclid Avenue on the northwesterly side of Ocean Place, thence in a southerly direction across Euclid Avenue for the distance of sixty-four (64') feet, thence easterly across Ocean Place for the distance of forty-one (41') feet to the east side of Ocean Place, thence northerly across Euclid Avenue for the distance of sixty-four (64') feet, thence westerly for the distance of forty-one (41') feet to the beginning.
- b. Parking is prohibited along the east side of Ocean Place within the intersection of Edgemont Drive.
- c. Parking is prohibited and the following areas are designated as loading or unloading zones to a maximum of ten (10) minutes duration only from 8:00 AM to 6:00 PM daily:
 1. On the north side of Euclid Avenue for a distance of seventy-nine (79') feet west of the corner of Ocean Place; and,
 2. On the south side of Euclid Avenue for a distance of eighty-nine (89') feet east to the corner of Ocean Place.

Section 2. Violations and Penalties.

- a. Any person violating or causing to be violated any of the provisions of this Ordinance shall be subject to a fine of not less than Two Hundred Fifty (\$250.00) Dollars and not more than One Thousand Two Hundred Fifty (\$1,250.00) Dollars.
- b. In addition to any other penalty provided by New Jersey Statute, any unoccupied vehicle parked or standing in violation of this Ordinance shall be deemed a nuisance and a menace to the safe and proper regulation of traffic and any police officer may provide for the removal of such vehicle. The owner shall pay the reasonable costs of the removal and storage, which may result from such removal before regaining possession of the vehicle.

Section 3. REPEAL, SEVERABILITY

- a. All ordinances or parts of ordinances inconsistent herewith are repealed, but only to the extent of such inconsistency.
- b. If any section, paragraph, subparagraph, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subparagraph, clause or provision so adjudged and remainder of this ordinance shall be deemed valid and effective.

Section 4. EFFECTIVE DATE

This Ordinance shall take effect immediately upon its final passage and publication as required by law.
