

ORDINANCE NO. 316

AN ORDINANCE PROVIDING FOR THE COST-SHARED PURCHASE OF A
CHERRINGTON 740XL BEACHCLEANER WITH THE BOROUGH OF ALLENHURST PURSUANT
TO THE INTERLOCAL SERVICES ACT, N.J.S.A. 40:8A-1, et seq.,
AND PROVIDING FOR THE COST THEREOF FROM THE CAPITAL IMPROVEMENT FUND
OF THE VILLAGE OF LOCH ARBOUR, COUNTY OF MONMOUTH

BE IT ORDAINED by the Board of Trustees of the Village of Loch Arbour, County of Monmouth, as follows:

Section 1. The Board of Trustees of the Village of Loch Arbour, pursuant to the Interlocal Services Act, N.J.S.A.40:8A-1 et seq., entered into an agreement with the Borough of Allenhurst to cost-share the purchase of a Cherrington 740XL Beach cleaner.

Section 2. The equipment purchase as stated above is a general improvement that the Village may lawfully undertake and the amount appropriated therefor is \$9,150.00.

Section 3. No debt is to be issued for said improvement and purchase and the cost of said improvement and purchase is to be financed from the funds presently accumulated in the Capital Improvement Fund of the Village of Loch Arbour to the extent of \$9,150.00.

Section 4. Repeal, Severability.

a. All ordinances or parts of ordinances inconsistent herewith are repealed, but only to the extent of such inconsistency.

b. If any section, paragraph, subparagraph, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subparagraph, clause or provision so adjudged and the remainder of this ordinance shall be deemed valid and effective.

Section 5. Effective Date

This Ordinance shall take effect immediately upon its final passage and publication as required by law.
