<b>HOUSEHOLD REFUSE</b> T	<ul style="list-style-type: none"> <li>WHEN: TUESDAY AND FRIDAY</li> <li>WHERE: REAR YARD</li> <li>Limited to 3 – 30 gallon containers per pick-up</li> </ul>
<b>APPLIANCES, WHITE GOODS, METAL</b> R	<ul style="list-style-type: none"> <li>WHEN: BY APPOINTMENT (Borough of Deal, 732.531.1454)</li> <li>WHERE: curbside</li> <li>APPLIANCES CONTAINING FREON (refrigerators, air conditioners, dehumidifiers, water coolers) are subject to an additional charge of \$20 for freon removal, payable to the Borough of Deal. Payment must be made in advance.</li> </ul>
<b>BATTERIES, HOUSEHOLD</b> *	<ul style="list-style-type: none"> <li>Regular alkaline batteries – dispose of with household trash</li> <li>Rechargeable batteries – return to location of purchase for recycling</li> <li>"Button" batteries - bring to the Municipal Offices for disposal</li> </ul>
<b>BRANCHES (SMALL) AND BRUSH</b> R	<ul style="list-style-type: none"> <li>WHEN: THURSDAY</li> <li>WHERE: curbside; <b>NOT PILED IN THE GUTTERLINE</b></li> <li>HOW: <b>CONTAINERIZED</b></li> <li><b>NOTE:</b> Branches must be less than 4' long and 3" in diameter; <b>DEBRIS LEFT AT THE CURB WILL NOT BE PICKED UP; CITATIONS WILL BE ISSUED FOR VIOLATIONS</b></li> <li>CONTRACTOR-GENERATED MATERIAL MUST BE REMOVED BY CONTRACTOR</li> </ul>
<b>BULK TRASH</b>  Note: Check the date for bulk pick-ups. Material must be at the curb no later than 7:00 AM on the day of pick-up. T	<ul style="list-style-type: none"> <li><b>WHEN: February 8, April 12, May 10, July 12, September 20, November 1</b></li> <li>WHERE: curbside</li> <li>WHAT: Furniture, lawn furniture, mattresses, rugs (tied, 4' lengths), clothes, chairs including beach chairs, cabinets, appliances (not containing CFC's)</li> <li>HOW: Containers weighing less than 50 lbs.</li> <li><b>CONTRACTOR-GENERATED MATERIAL MUST BE REMOVED BY CONTRACTOR</b></li> </ul>
<b>COMMINGLED: BOTTLES, CANS, PLASTIC CONTAINERS</b> R	<ul style="list-style-type: none"> <li>WHEN: 1<sup>st</sup> and 3<sup>rd</sup> Wednesday</li> <li>WHERE: curbside by 7:00 AM</li> <li>WHAT: Aluminum cans, tin or bi-metal cans, glass bottles and jars, plastic containers for milk, juice, soda, detergent, bleach.</li> <li>HOW: Rinsed and placed in a maximum 30 gallon container</li> <li><b>NO FLOWER POTS, PRESCRIPTION MEDICINE BOTTLES, LIGHTERS, RAZORS, PAINT, VARNISH, MOTOR OIL OR PESTICIDE CONTAINERS, WINDOW PANES, LIGHTBULBS, CRYSTAL ITEMS, DISPOSABLE ALUMINUM TRAYS OR CONTAINERS, ALUMINUM FOIL</b></li> </ul>
<b>CONCRETE, BRICK</b> *	<ul style="list-style-type: none"> <li>See Bulk Trash information</li> <li><b>CONTRACTOR-GENERATED MATERIAL MUST BE REMOVED BY CONTRACTOR</b></li> </ul>
<b>CORRUGATED CARDBOARD</b> R	<ul style="list-style-type: none"> <li>WHEN: 1<sup>st</sup> and 3<sup>rd</sup> Wednesday</li> <li>WHERE: curbside by 7:00 AM</li> <li>HOW: "Broken down" (flattened) and tied into bundles weighing less than 50 lbs.</li> </ul>
<b>GRASS</b>	<ul style="list-style-type: none"> <li>Banned from the landfill and will not be picked up.</li> <li>Experts recommend leavings clippings on the lawn.</li> </ul>
<b>CHRISTMAS TREES</b> R	<ul style="list-style-type: none"> <li>WHEN: January</li> <li>WHERE: curbside only</li> <li>HOW: FREE OF DECORATIONS, not bagged</li> </ul>

<b>HOUSEHOLD HAZARDOUS WASTE</b> *	<ul style="list-style-type: none"> <li>• WHEN: BY APPOINTMENT ONLY at (732) 683-8686</li> <li>• WHERE: MONMOUTH COUNTY RECLAMATION CENTER, SHAFTO ROAD, TINTON FALLS</li> <li>• WHAT: Pesticides, herbicides, solvents, paint, pool chemicals, motor oil, antifreeze</li> </ul>
<b>LEAVES</b> R	<ul style="list-style-type: none"> <li>• WHEN: <b>JANUARY 1 THROUGH SEPTEMBER 30</b></li> <li>• WHERE: curbside only (containerized)</li> <li>• WHEN: <b>OCTOBER 1 THROUGH DECEMBER 31</b></li> <li>• WHERE: at the curb</li> <li>• HOW: CLEAN PILES OF LEAVES (<b>NO BRUSH</b> or other debris may be included)</li> </ul>
<b>MIXED PAPER</b> R	<ul style="list-style-type: none"> <li>• WHEN: 1<sup>st</sup> and 3<sup>rd</sup> Wednesday</li> <li>• WHERE: curbside by 7:00 AM</li> <li>• WHAT: Magazines, paperback books, computer paper, catalogs, writing paper, office paper, envelopes, fax paper, non-metallic wrapping paper, real estate books, NCR paper, sales flyers</li> <li>• HOW: May either be securely tied in bundles weighing less than 50 lbs. or placed in a covered 30 gallon container</li> <li>• <b>NO CEREAL BOXES, PIZZA BOXES, PLASTIC COATED PAPER, PAPER NAPKINS OR TOWELS, BLUEPRINTS;</b> dispose of these items with household trash</li> </ul>
<b>NEWSPAPER</b> R	<ul style="list-style-type: none"> <li>• WHEN: 1<sup>st</sup> and 3<sup>rd</sup> Wednesday</li> <li>• WHERE: curbside by 7:00 AM</li> <li>• WHAT: Newspaper and newsprint</li> <li>• HOW: Tied into bundles not more than 12" high weighing less than 50 lbs.</li> </ul>
<b>PAINT AND PAINT CANS</b> T	<ul style="list-style-type: none"> <li>• <b>Open Cans (less than 1" in the can)</b></li> <li>• WHEN: Tuesday and Friday</li> <li>• WHAT: latex or oil based paints</li> <li>• WHERE: Rear Yard (place with household trash in containers for disposal)</li> <li>• HOW: Remove lid, <b>allowing the liquid to dry.</b></li> <li>• <b>Full Cans</b> – latex or oil-based paint</li> <li>• WHEN: BY APPOINTMENT ONLY</li> <li>• WHERE: Monmouth County Reclamation Center (732) 683.8686 (Household Hazardous Waste by appointment)</li> </ul>
<b>PLANTS (HOUSE)</b> T	<ul style="list-style-type: none"> <li>• With household trash (does not include outdoor plants, shrubs or branch clippings – see BRUSH for proper disposal method)</li> <li>• <b>DO NOT LEAVE AT THE CURB</b></li> </ul>
<b>TELEPHONE BOOKS</b> R	<ul style="list-style-type: none"> <li>• July</li> <li>• <b>INCLUDE WITH MIXED PAPER</b></li> </ul>
<b>TIRES</b> *	<ul style="list-style-type: none"> <li>• by special pick-up only, Borough of Deal 732.531.1454</li> <li>• \$2 each; \$5 each for tires on rims; payable in advance to the Borough of Deal</li> </ul>
<b>COMPUTERS &amp; ELECTRONICS</b> R	<ul style="list-style-type: none"> <li>• WHEN: By appointment only</li> <li>• Monmouth County Reclamation Center, Gate A, Main Entrance or Long Branch Recycling Facility, 378 Atlantic Avenue (across from Pleasure Bay Park) (732) 571-6520</li> <li>• WHAT: Computer cases, CPU's, keyboards, mice, monitors, scanners, printers, cables, laptops, peripherals, TV's (no larger than 42"), radios, telephones, cameras, VCR's, DVD players, stereo components</li> </ul>
